Established in 2002, is **the country's only university devoted entirely to open and distance higher education and lifelong learning.**

Open University of Cyprus,

- offers interdisciplinary, career-oriented, academically rigorous and creatively stimulating Bachelor's, Master's and PhD degree programmes in both 'classical' and 'cutting edge' scientific areas organized through its three Faculties (Humanities and Social Sciences, Pure and Applied Sciences, Economics and Management)
- develops wide-ranging research work in cutting-edge scientific fields and participates in externally funded research projects
- fosters strategic partnerships with universities, research centers and other stakeholders in Cyprus and abroad

RESEARCH AT OUC

Research at Open University of Cyprus is wide-ranging and interdisciplinary, and focuses on the advancement and transfer of knowledge through the creative output of its faculty and researchers. Under its internationalization strategy, OUC supports individual projects of its academic and research staff, and develops strong partnerships with foreign research teams that involve local and international research projects with academia, the business world, and other research organisations.

OUC is actively involved in research in the following areas:

- culture, theatre, history, and archeology
- communications and new journalism
- educational sciences, adult education and lifelong learning
- literature and linguistics
- healthcare policy and administration, health economics
- business administration, economics and management
- educational technology
- environment, ecology and climate change
- information and communication technologies, social information systems, artificial intelligence, telecommunications
- European and commercial law.

Research activities are financed by the University's state-funded budget, or receive external funding from various national (esp. Cyprus Research Promotion Foundation) and European and international programmes such as Erasmus+, Horizon2020, Life+, ENPI, INTERREG, ICT PSP, and COST.

In addition to independent research, OUC's six (6) research labs support collaborative research and engage faculty and students from across the University:

- Computational Cognition Lab
- Cybersecurity and Telecommunications Research Lab
- Educational Technology Lab
- Terrestrial Ecosystems Management Lab
- Cyprus Center for Algorithmic Transparency

These dedicated research laboratories provide a vibrant research environment for OUC students, academics and researchers, as well as opportunities for the effective link between academia, business and industry. The resulting synergies enable basic and applied research, and research outcomes for the benefit of society.

RESEARCH LABS

Chemical Engineering and Engineering Sustainability Lab

The Laboratory combines new scientific areas of Sustainable Development, Environmental Management and Engineering as well as Chemical Engineering. Its main research areas are the following:

- Cities Metabolism, Smart Cities, Strategic Development Plans, Sustainable Development Programmes, Circular Economy and Industrial Co-habitation Strategy.
- Waste Prevention practices and development of sustainability indicators (economic, social, environmental) and implementation of environmental management systems in various sectors.
- Environmental Impact Studies and Environmental Analysis / Risk Assessment / Multi-criteria and Life Cycle Analysis Models.
- Development of techniques - technologies for the treatment of solid and liquid waste, bio-systems, hazardous waste, composting, etc.

Computational Cognition Lab

Research carried out at the Computational Cognition Lab (CCLab) seeks to understand cognitive processes often associated with individual or collective intelligence — such as learning, reasoning, sensing, communication, cooperation — and how these are employed by humans and other organisms in everyday life. Emphasis is placed on the development of formal computational models for various aspects of cognitive processes and the analysis of the formal implications that such models have.

Cybersecurity and Telecommunications Research Lab

The Cybersecurity and Telecommunications Research Lab (CTRL) has been established and is led by Professor Stavros Stavrou. CTRL's research activities are concentrating in the following areas: cybersecurity, protection of critical infrastructures, wireless communications and networks and localisation of wireless systems.

Educational Technology Lab

OUC Laboratory for Educational Technology conducts research and publishing in the areas of open and distance learning methodologies, internet safety, mobile and adaptive learning, human-machine interaction and ICT utilization in school education.

Terrestrial Ecosystems Management Lab

Work in the Terrestrial Ecosystems Management Lab (TemLab) is based on traditional approaches to ecosystem management coupled with landscape ecology principles, namely the importance of spatial configuration of ecological processes, and the emphasis on larger spatial extents. TemLab research revolves around three pillars that intertwine: a) Mediterranean Ecosystems with emphasis on islands and mountains, b) Landscape based approach to conservation, c) Spatial Analysis for species and habitats modelling and ecosystem services.

Cyprus Center for Algorithmic Transparency (CyCAT)

The Cyprus Center for Algorithmic Transparency, operating at OUC, aims to establish a network of researchers with key expertise in the areas of informatics and digital literacy. Among other broader impacts, CyCAT aims to create digital tools / databases that are relevant to the needs of Cypriot users and which will be used to raise awareness about algorithmic bias (in particular, biases found in information access systems that the public routinely uses), the creation of digital material related to the development of such systems, as well as the strengthening of actions and interventions in Cyprus on the importance of digital and algorithmic literacy.

The OUC research team includes Assistant Professor Jahna Otterbacher (coordinator), Professor Michalinos Zembylas and Associate Professor Loizos Michael. The advanced partner organizations are the University of Sheffield (UK), the University of Haifa (Israel), the University of Trento (Italy) and the University of Edinburgh (UK).

SHORT VITA

George Deligiannakis is a graduate of the Department of History and Archeology (School of Philosophy) of the University of Athens (1999). He completed his MPhil postgraduate studies at the University of Oxford (2002) and in 2007 he was awarded a PhD in Ancient History from the same university. He taught as Lecturer in the Department of Philology at the University of Patras (2007-2008), while in 2008 he was appointed Lecturer and then Assistant Professor (2012) and Associate Professor (2017) of Late Antiquity at the Open University of Cyprus.

He has published about fifty articles and studies in international scientific journals and collective volumes. His latest monograph entitled *The Dodecanese and the Eastern Aegean Islands in Late Antiquity, AD 300-700*, was published by Oxford University Press. He has received research fellowships from Princeton and Ohio State Universities. He has also been a fellow of the Alexander von Humboldt Foundation (2017-2019), and a visiting professor at the University of Bologna (2020).

SHORT VITA

Dr. Efthymiadis studied Law at the University of Athens and Greek Literature at the University of Crete, Greece. He then specialised in Byzantine Philology through his PhD thesis at the University of Oxford, UK. In his thesis, he dealt with the hagiography produced during the period of Iconoclasm, especially the Life of Patriarch St Tarasios (1998). He has published numerous articles on Byzantine hagiography, prosopography and historiography. He was the editor of a two-volumes book entitled *Ashgate Research Companion to Byzantine Hagiography* (2011, 2014). Sixteen of his articles were reprinted at the distinguished series of Variorum Reprints. He also worked on the area of South Italy, Phocea in Asia Minor, and Lesbos. Together with Anthony Kaldellis he published the *Byzantine Prosopography of Lesbos*.

Among the research projects, which he either coordinated or participated as a partner were: The Correspondence of Ignatios the Deacon (together with Cyril Mango, 1993-1997); The Hagiography of the Palaiologan Period (National Research Foundation of Greece, 2005-2008); A literary reading of the Theophylaktos Simokattes' Ecumenical History (OUC, 2008-2010), The Social History of Hagia Sophia of Constantinople (OUC, 2011-2013), and Readings of Aristotle.

Dr Maria Gravani is an Assistant Professor in Continuing/Adult Education at the Open University of Cyprus, Faculty of Humanities and Social Sciences, and Academic Coordinator (at the OUC) for the MA in "Continuing Education and Lifelong Learning" & the International Masters on "Adult Education for Social Change" (IMAESC-Erasmus Mundus).

She is an elected member of the Steering Committee of ESREA (European Society for the Research in the Education of Adults) since 2017, and sits in the Editorial Advisory Board of RELA (*European Journal for Research on the Education and Learning of Adults*) and of the *Studies in Adult Education and Learning*.

Her main research interests include adult teaching and learning in different contexts (second chance, distance, higher education, education of adult migrants), professional training and professionalisation of adult educators, lifelong learning, methodologies of qualitative research. She has extensively researched and published in the field. Before moving to Cyprus, Maria worked as a ESRC postdoctoral fellow at the University of Bristol (UK), a research development officer at Trinity College, University of Dublin (Ireland), a tutor for UCL (University of London) and the Hellenic Open University, and a part-time lecturer for the University of Peloponnese.

She holds a PhD in Continuing Education (2003) (State Scholarships Foundation Scholar), an MEd in Educational Management, Administration & Policy (1999) from the Graduate School of Education, University of Bristol, UK, and a B.A. (Honours) in Greek Philology (specialized in Classical Studies) from the Aristotle University of Thessaloniki, Greece (1997).
